NOTICE INVITING TENDER

Additional Chief Engineer (Proc.) invites "On line Tenders " from registered manufacturers whose works in India having GST registration for supply of SCADA/DMS enabling components/equipments i.e. supply, erection, commissioning & testing of 11 KV RMUs as per DGVCL's specifications in the area of DGVCL circles. All bidders, in respect of tender items must have vendor registration with the GUVNL or its subsidiary companies viz. DGVCL/ MGVCL/ UGVCL/ PGVCL/ GETCO/GSECL prior to the date of opening of technical bid of the tender. However, if the new Vendor, who has submitted their application for Vendor Registration with all required fees and all the requisite documents prior to the date of publication of Tender in the Newspaper shall be allowed to participate in the Tender, subject to the condition that they should submit Vendor Registration Certificate before opening of price Bid.

If the firm fails to submit the Vendor Registration Certificate before opening of Price Bid, their Technical Bid shall be rejected and price Bid shall not be opened. However, the process of tender shall not be delayed by the Company merely because of vendor application of a bidder is in process. The participating bidder must enclose copy of Receipt of the fees paid towards Vendor Registration along with the Tender Fees / EMD payment receipt.
